WHEREAS, Chapter 78 permits the Borough, after proper certification with regard to the cost of such removals, to charge such costs as a lien against the lands and properties in question, and



**RESOLUTION AUTHORIZING SETTLEMENT OF A REVERSE TAX
APPEAL**

WHEREAS, the Borough of Bellmawr (“Borough” and/or “Bellmawr”) determined that it is in the best interests to retain the services of Special Counsel to assist the Borough in prosecution of real estate tax appeals for the Borough (Affirmative Appeals) regarding certain properties believed to be substantially under-assessed; and

WHEREAS, the Township filed affirmative tax appeals with regard to a certain property known on the tax map as Block 173.01, Lot 4 and Block 159.01, Lot 4, with a street address of 151 Benigno Boulevard and Walnut Avenue (“Property”); and

WHEREAS, Rosemary J. Loverdi appeared on behalf of the Property owner; and

WHEREAS, Special Tax Appeal Counsel recommended a settlement which will increase the combined assessment from \$5,269,000 to \$13,500,000 for 2020, which will result in an increase of taxes of \$316,400 for 2020; and which will increase the combined assessment from \$5,269,000 to \$12,853,300 for 2021, which will result in an increase of taxes of \$295,714 for 2021; and which will increase the combined assessment from \$5,269,000 to \$15,057,300 for 2022, which will result in an increase of taxes of \$374,305 for 2022; and which will increase the combined assessment from \$5,269,000 to \$14,213,000 for 2023 which will result in an increase of taxes of \$337,726 for 2023; and which will increase the combined assessment from \$5,269,000 to \$12,739,000 for 2024; and

WHEREAS, Special Counsel and Ms. Loverdi negotiated a staggered payment plan, the appeals will be settled according to the following schedule:

The 2020 appeal will be settled immediately.

The stipulation of settlement for the year 2021 and 2022 will be signed immediately and held in escrow by the plaintiff’s attorney but will not be submitted to the Tax Court before October 1, 2024.

The stipulation of settlement for the year 2023 will be signed immediately and held in escrow by the plaintiff’s attorney but will not be submitted to the Tax Court before October 1, 2025.

WHEREAS, Special Tax Appeal Counsel’s contract dictates they receive 21.5% of the total recovery; and

WHEREAS, the Borough tax assessor approves this settlement; and


NOW, BE IT HEREBY RESOLVED, THAT THE BOROUGH COUNCIL OF THE BOROUGH OF BELLMAWR HEREBY APPROVES the proposed settlement with regard to Block 173.01, Lot 4 and Block 159.01, Lot 4, with

a street address of 151 Benigno Boulevard and Walnut Avenue whereby the assessment for 2020 will increase to \$13,500,000; and the assessment for 2021 will increase to \$12,853,300; and the assessment for 2022 will increase to \$15,057,300; and the assessment for 2023 will increase to \$14,213,000; and the assessment for 2024 will be set at \$12,739,000; and

BE IT HEREBY FURTHER RESOLVED, THAT THE BOROUGH COUNCIL OF THE BOROUGH OF BELLMAWR HEREBY APPROVES the fee for Special Tax Appeal Counsel of \$68,026 for 2020, \$63,578 for 2021, \$80,475 for 2022, and \$72,611 for 2023.



SHARED SERVICES AGREEMENT
BY AND BETWEEN
THE COUNTY OF CAMDEN
AND
BOROUGH OF BELLMAWR

THIS DOCUMENT constitutes a Shared Services Agreement pursuant to N.J.S.A. 40A:65-1 et seq., entered into between the County of Camden, a body politic and corporate of the State of New Jersey with offices located at 520 Market Street, Camden, New Jersey 08102, (County), and the Borough of Bellmawr, a body politic and corporate of the State of New Jersey with offices located at 21 E. Browning Road, Bellmawr, New Jersey 08031 (Borough). The date of execution of this Agreement is the _____ day of _____, 2023.

WITNESSETH:

WHEREAS, the County of Camden seeks to provide for the efficient and effective removal of snow on County roads throughout the County of Camden; and

WHEREAS, the County recognizes that certain Camden County municipalities have the capacity, upon request and on short notice, to remove snow from designated County roadways within their respective municipalities, in a timely manner, during the course of or immediately following a winter storm; and

WHEREAS, the County desires to make arrangement for the unforeseeable circumstances which winter storms often present under which additional snow removal capacity is needed; and

WHEREAS, the County has, in the past, made similar arrangements under which the Municipal partners were compensated with pro-rated allotments of road salt and/or calcium; and

WHEREAS, all other terms and conditions of the Shared Services Agreement shall be subject to review and approval by the Office of County Counsel; and

WHEREAS, in order to facilitate joint participation by the Borough of Bellmawr for salt and plowing of County roads in the Borough of Bellmawr, it is necessary for the County to enter into a Shared Services Agreement pursuant to N.J.S.A. 40A:65-1 et seq with the Borough of Bellmawr for this purpose; and

WHEREAS, to that end the Camden County Board of Commissioners is desirous of entering into a Shared Services Agreement with the Borough of Bellmawr with the provisions set forth herein including but not limited to the following provisions:

1. The County will initially deliver 115 tons of salt beginning with the winter season 2023/2024, of which 100 tons is for County use and 15 tons for Bellmawr;
2. 15 Tons of Salt will be delivered per storm for Bellmawr;
3. Bellmawr will load Camden County trucks during their emergency work ours as needed;
4. Bellmawr will salt and plow Camden County Roads Nos. 659, 753, 658 and 551 located in the Borough of Bellmawr; and

WHEREAS, by Resolution No. 8 adopted October 19, 2023, the proper County officials were authorized to execute an appropriate Shared Services Agreement; now, therefore,

IN CONSIDERATION of the mutual promises set forth herein, the parties hereto agree as follows:

1. TERM AND TERMINATION

This agreement shall be for the 2023 – 2024 winter snow/ice season effective upon adoption of the County resolution. Either party may terminate this

agreement at the conclusion of a snow season and not before April 1st of each year, upon sixty (60) days written notice to the other party.

2. DEFINITIONS

The term "winter storm" as used in this agreement shall refer to ice or snow accumulation on roadways in Camden County which:

- a. Is the subject of a "winter storm" declared by the Director of the Camden County Department of Public Works and/or his designee, which results in the mobilization of salting or plowing procedures by the County, on County roads.

3. Borough RESPONSIBILITIES

The Borough shall provide for snow plowing and ice control, salting and sanding (hereinafter "maintenance"), curb to curb on County roads, (Nos. 659, 753, 658 and 551), during and immediately after each winter storm of the storm seasons for the term of this Agreement. Maintenance shall be for the duration of each winter storm and for the 24-hour period immediately after the end of precipitation (hereinafter "treatment period"). The Borough maintenance shall be performed by the Borough, on an as needed basis, at the request of and under the direction of the County's Department of Public Works. The County acknowledges that not all Borough vehicles have salting and sand spreader capabilities.

It is imperative that the Borough contact the Camden County Department of Public Works immediately upon maintenance obligations. The Borough must contact the Camden County Department of Public works at any time throughout the day or night by calling the County's 24-hour telephone system at (856) 566-2980.

4. COMPENSATION

As a component of transformation and sharing services among county affiliate agencies and the County proper, these services will be provided by the Borough at no charge back to the County proper.

The Borough may, upon written request to the Director of Public Works, access the County's weather service and receive a pro-rata allotment of road salt and calcium as needed and described herein.

5. ADHERENCE TO LOCAL PUBLIC CONTRACTS LAW

In accordance with N.J.S.A. 40A:65-1, if any party performing a service on behalf of another party or parties to this agreement utilizes the services of a private contractor to perform all or most of such service, or all or most of a specific and separate segment of the services so contracted for, such party shall be required to award the agreement for the work to be performed by a private contractor under such agreement in accordance with the "Local Public Contracts Law" (N.J.S.A. 40 A: 11-1 et seq.).

6. AUDIT

Pursuant to the Single Audit Act of 1984, the PCFA agrees to permit the County and/or its agents to examine all records relevant to this agreement and shall make the same available upon demand at a reasonable time and place for the purpose of auditing the records, reports, and documents relative to this agreement.

7. RIGHT TO INSPECT

The Borough shall permit the County or its authorized representative to make visits to the site or sites where the specified services are being

provided for the purpose of assuring the Borough's compliance with the terms of this agreement.

8. MUTUAL INDEMNIFICATION

The Borough shall indemnify, hold harmless and defend the County, from all claims and lawsuits arising from negligence on the part of the Borough and its employees. Similarly, the County will reciprocate as a result of acts of negligence performed by the County and its employees.

9. INSURANCE

The Borough shall provide and maintain during the term of this agreement adequate insurance coverage for the services to be performed pursuant to this agreement. Said insurance shall include but not be limited to general liability and workers compensation insurance.

10. NOTICE

All notice hereunder shall be in writing and mailed, postage paid, certified mail, return receipt requested to the County by directing the same to the Director of Public Works, Charles J. DePalma Complex, Egg Harbor Road, Lindenwold, New Jersey 08021 and to the Borough by directing the same to the Mayor, 21 El Browning Road, Bellmawr, New Jersey 08031.

11. MISCELLANEOUS


The following provisions shall apply to this agreement:

- a. Construction of this Agreement
The parties acknowledge that this agreement was prepared under New Jersey Law and shall therefore be interpreted under the laws of that State.
- b. Amendments
This agreement may not be amended, altered, or modified in any manner except in writing signed by the parties hereto.
- c. Headings
This section and other headings contained in this agreement are for references only and shall not affect the meaning and interpretation of this agreement.
- d. Invalid Clause
The invalidity of any clause contained herein shall not render any other provision invalid and the balance of this agreement shall be binding upon all parties hereto.
- e. Entire Agreement
This agreement shall consist of the entire agreement of the parties and it is acknowledged that there are no side or oral agreements relating to this undertaking set forth herein.
- f. Assignability
This agreement and all rights, duties, and obligations contained herein may not be assigned without the County's prior written permission.
- g. Affirmative Action
The affirmative action provisions set forth in the documents attached hereto are incorporated herein and made a part hereof.


- h. Americans with Disabilities Act
The Americans with Disabilities Act provisions set forth in the documents attached hereto are incorporated herein and made a part hereof.
- i. Funding
In accordance with the provisions of N.J.S.A. 40A:11-15, this agreement is subject to the availability and appropriation of sufficient funds in the year in which it is in effect.
- j. Waiver
It is understood and agreed by the parties that a failure or delay in the enforcement of any of the provisions of this agreement by either of the parties shall not be construed as a waiver of those provisions.
- k. Binding Agreement
This agreement shall be binding upon the parties hereto and their respective heirs, executors, administrators, successors, or assigns.



**SHARED SERVICES AGREEMENT
BY AND BETWEEN THE BOROUGH OF BELLMAWR AND THE CITY OF
GLOUCESTER CITY, FOR FUEL PURCHASES**

Amending agreement between the Borough of Bellmawr, 21 East Browning Road, Bellmawr, NJ 08031 (“Bellmawr”) and the City of Gloucester City, 512 Monmouth St., Gloucester City, NJ 08030 (“Gloucester City”). The effective date of this Agreement is the first day of January 2023.

WHEREAS, the Borough of Bellmawr (hereinafter Bellmawr) is a body politic organized under the laws of the State of New Jersey and located in the County Camden; and

WHEREAS the City of Gloucester City (hereinafter Gloucester City) is a body politic organized under the laws of State of New Jersey and located in the County, of Camden; and

WHEREAS, the Uniform Shared Services and Consolidation Act, N.J.S.A. 40A:65-1 et seq. (the “Act”), authorized local units of this State to enter into an agreement with any other local unit or units to provide or receive any service that each local unit participating in the agreement is empowered to provide or receive in its own jurisdiction; and

WHEREAS, Gloucester City is in need of a fuel source due to an emergent breakdown of its pumping equipment; and

WHEREAS, Borough of Bellmawr is willing to assist Gloucester City by permitting usage of its fuel facilities; and

WHEREAS, in the spirit of inter-municipal cooperation, and in furtherance of the principles underlying the Act, Bellmawr and Gloucester City (collectively, the “Parties”), have negotiated an Agreement for the shared provision of the services within their respective jurisdictions; and

WHEREAS, the terms and conditions of this undertaking are set forth below; and

WHEREAS, the Parties have each duly authorized their proper officials to enter into and execute this Agreement; and

NOW THEREFORE, AND IN CONSIDERATION OF THE MUTUAL PROMISES SET FORTH HEREIN, BELLMAWR AND GLOUCESTER CITY AGREE AS FOLLOWS:

1. **PURPOSE.** In an effort to more economically and efficiently provide governmental services, the governing bodies of Bellmawr and Gloucester City have entered into negotiations wherein Gloucester City would utilize on a temporary basis, Bellmawr’s fueling facility until the Gloucester City facility is brought back online and fully operational. The legal authority for such Interlocal Services is found in N.J.S.A 40:8A-1 et seq. and N.J.A.C. 5:23-4.6 et seq. The governing bodies of Bellmawr and Gloucester City have determined that it is in the mutual best interest of each municipality for Gloucester City to provide the services to Bellmawr, and in return, Bellmawr will compensate Gloucester City as set forth herein. Gloucester City will provide the services as set forth within this agreement for so long as Gloucester City has a need therefore.

2. **TERM.** This Agreement shall commence on January 1, 2023 through December 31, 2025. However, either party has the right to terminate this Agreement for any reason on ninety (90) days written notice to the other party following the adoption of a Resolution by the governing body of the entity terminating this Agreement authorizing the termination. In the event that either party defaults in the performance of any of its obligations under this Agreement after receiving written notice of same and failing to cure such default within thirty days of said written notice, the non-defaulting party shall be entitled to terminate this Agreement.

3. **SERVICES.** Bellmawr shall permit Gloucester City access to its fueling facilities.

4. **PAYMENT.** In consideration for the services rendered by Bellmawr, Gloucester City shall reimburse Bellmawr its direct cost to supplying fuel to Gloucester City plus a six (6%) percent administrative fee.

5. INDEMNIFICATION. Bellmawr and Gloucester shall mutually indemnify and hold harmless the other, its officers, employees and agents, harmless from and against any and all claims of whatever nature or type arising from the provision of the services identified herein, so long as the actions upon which the demand or claim, or assertion of liability are founded, were performed in the course of carrying out official duties on behalf of either parties hereto and were not out of the scope of services or performed in bad faith; and did not constitute actual fraud, actual malice, willful misconduct, intentional wrong doing or a criminal act. Such indemnification shall include payment of reasonable attorney's fees and costs in the defense of any claim made by a third person. This indemnification is not limited to any insurance coverage afforded to Gloucester City or Bellmawr.

6. ENTIRE AGREEMENT. This Agreement represents the entire agreement between the Parties and cannot be changed or modified orally. This Agreement may be supplemented, amended or revised only by a writing that is signed by all of the parties hereto.

7. SEVERABILITY. If any part of this Agreement shall be held to be unenforceable, the rest of this Agreement shall nevertheless remain in full force and effect.

8. WAIVER. Failure to insist upon strict compliance with any of the terms, covenants, or conditions of this Agreement at any one time shall not be deemed a waiver of such term, covenant, or condition at any other time nor shall any waiver or relinquishment of any right or power herein at any time be deemed a waiver or relinquishment of the same or any other right or power at any other time.
